BACKGROUND

The proposed amendments are made in coherent to ASUCR 2016 - 2017 budget. Chapter VIII, Section 6, Subsection C is amended due to increase and decrease of stipend amount, and abbreviations. Chapter VIII, Section 7, Subsection F can be removed since stipend proposal required a 2/3 vote of the ASUCR Senate and stipend can be exceed 25% with a 2/3 vote of the ASUCR Senate.
