<b>TITLE</b>	General Amendments to Chapter XXXII - 1

**BACKGROUND**

The current Chapter XXXII on Code of Conduct only applies to Senate meetings and only holds Senators responsible. There were also ambiguity in grounds of removal, grammatical errors, and redundancy of information. As a result, the proposed Chapter XXXII on Code of Conduct applies to all meetings involving Senators, Directors, and Executive Cabinet. Furthermore, the proposed senate bill specifies guidelines of removal, fixes the grammatical errors, and is shortened and concise.

**THE ASUCR SENATE HEREBY AMENDS CHAPTER XXXII OF THE ASUCR BYLAWS AS FOLLOWS,**

1. **Chapter XXXII.** The current Chapter XXXII on Code of Conduct shall be removed and replaced with proposed Chapter XXXII on Code of Conduct.

**Chapter XXXII  
Code of Conduct**

Section 1. Purpose

- (a) This chapter shall set forth a standard for ASUCR meetings and the conduct that is expected of ASUCR representatives.

Section 2. Overview

- (a) Meetings shall run by the presiding chair using Robert’s Rules of Order, Newly Revised, the current edition; in order to lead the meeting as efficiently as possible. There is an understanding among Senators, Directors, and Executive Cabinet who represent the undergraduate populous that a certain conduct must be in place at all times. If a member is not able to conduct themselves in a manner that is respectable and professional during meetings the presiding chair may remove this person from the meeting.

Section 3. Guidelines for Removal

- (a) A member may be temporarily removed:
  - i. When the individual does not acknowledge the presiding chair's right to hold order and chooses to ignore plea for order;
  - ii. When the individual uses foul language.
- (a) A member may be removed for the entire meeting:
  - i. When the individual attempts to verbally attack another individual during the meeting, included but not limited to:
    - 1. the use of foul language.
  - ii. When the individual attempts to physically attack another individual during the meeting.

Section 4. Enforcement

- (a) No vote is necessary for the suspension of a member and will fall under the right of the presiding chair's discretion. If at any case a member of Senate is suspended for an entire meeting more than two (2) times during the academic year, the Act of Censure will automatically occur.
